2. **Chaurjahari Municipality Office** invites electronic bids from eligible bidders for the following projects under National Competitive Bidding procedures.

4. Bid must be submitted by epp system from pppo website before **12:00 PM on 30th day (2079/06/30) of Publication**. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 PM on 30th day (2079/06/30)** at the **Chaurjahari Municipality Office**. If the bidder's representative **does not choose** to attend for opening, there will be no objection in opening the tender.
6. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security amounting to a minimum of 2.5% of estimated amount, which shall be valid for **30 days** beyond the validity period of the bid. If the bidder wishes to submit the bid security in the form of cash, the amount should be deposited in **Banijya Bank Ltd.
